



Additional information - please read carefully 😊

1. entry (online only)

The entry is only valid when:

- the entry is done online

AND

- two timeslips (2023 and/or 2024) are uploaded (all sportsman classes)

AND

- the entry fee has been paid

AND

- a copy of your passport/ID is uploaded

Only valid entries will be processed!

2. additional services (see notice board „Info Pit Space“)

2.1 additional pit space NEAFP-classes + JDB

- if you need additional space, please click while registration; please see also the information on the virtual notice board, only the listed options are available, please be sure to specify what the additional space will be used for

2.2 additional team-tickets

- available for **EUR 70.00** each (seats in south stands block A-D, not numbered) - only for team members!

2.3 electricity

- all sportsman classes will get electricity in the paddock, the costs are included in the entry fee
- FIA/FIM E classes have to specify their requirement (220 V/380 V), every driver/rider has to pay for it

3. licenses

- the DMSB dragster rules apply for the NEAFP classes, the FIM E regulations for drag bikes and FIA regulations for the European Drag Racing Championship

- only valid drag racing licenses from DMSB or a foreign sport authority (incl. start permission) authorise the participation of the event

- the vehicle class selected on the entry form can't be changed after final close of registration; renaming can only be done for technical reasons; the decision on this is made by the Clerk of the Course

4. startline access

(attention: separate ticket required, will be issued against signature during administrative check)

JDB / JDB = 1 assistant PET / ETB / SCB = 2 assistants SPET / PCD / SG / SC / CC / STG / FB = 3 assistants

FIA classes = 6 assistants (exception: TF = 7 assistants)

FIM E classes = 4 assistants



5. qualifying

- participation in the first round of qualifying on **Friday** is only allowed with administrative/technical check on Thursday **and** attendance at the drivers briefing
- two additional qualification rounds are scheduled for **Saturday**; elimination rounds start at 4 p.m. for some classes

7. boxes

- boxes will only be rented **upon request**, please contact: bmc@hockenheimring.de

8. team hospitality

- the Hockenheim-Ring GmbH is in charge of the catering rights in the whole event area. The selling of food and beverages is generally prohibited. If you are planning to operate a hospitality facility, please note that this requires the approval of Hockenheim-Ring GmbH before the event

9. sales of team souvenirs

- all commercial activities in the paddock, such as the sale of merchandising articles or the offering of services, require the permission of the organizer as well as a permission from the City of Hockenheim
- if you are unable to submit this permissions, you may be expelled from the premises
